Prayer Ministry Guidelines, Appointment Policy & Indemnity Release

Welcome to the Wilmington Healing Center, it is a privilege to serve you. To ensure our work together begins with clear expectations and communication, the following guidelines have been provided. If you agree with the information presented here, please acknowledge your acceptance by initialing where space is provided and signing below. When you come to Wilmington Healing Center for ministry, come prepared to ask the Lord to search your heart like David did in Psalm 139:23-24. Ask God to show you the things troubling you, and to expose the sin in your life that it may be confessed. Then ask God to set your feet on the path toward His everlasting ways and we will encourage your growth and healing at Wilmington Healing Center.

There is no guarantee that prayer ministry will improve your life or your health, but we hope it will improve your relationship with God and bring restoration.

Throughout ministry time you may be given suggestions for consideration, but you won't be told what to do and there won't be an attempt to fix you. Any true healing, deliverance and restoration comes from God, our ministers are just facilitators of that process. You will be encouraged to seek God for direction and guidance; however, you are responsible for your own life choices and decisions. God's direction for you, as you perceive it, may send you upon a difficult path – sometimes people lose jobs, relationships, health or home when they follow what they hear as God's direction.

Our prayer ministers will facilitate a safe and comfortable setting for introspection, confession of sins and prayer for deliverance from spiritual bondage. We will protect your private information and ensure the maintenance of confidentiality. We will teach from the Holy Bible and together we may discuss scriptures pertinent to your needs.

If you choose, we can explore the deep wounds of the past and ask God to bring His divine healing and restoration to those places in your heart. Sometimes distressing and unresolved memories may surface during prayer ministry that may include high levels of emotional or physical sensations. Subsequent to ministry sessions, dreams, memories, flashbacks and feelings may surface. If this is the case, you may find your emotional state worsens before it improves. The Wilmington Healing Center does not provide urgent care or emergency mental health services. We will encourage you to develop a strong support system in your life for ministry aftercare, emergencies, and ongoing support. This may include your church, a prayer team, a support group, trusted family and friends.

Prayer Ministry Guidelines

I acknowledge the Wilmington Healing Center ministers are not licensed counselors, therapists, medical or psychological practitioners. Ministers are prayer facilitators only.

If I am currently involved in being abused or abusing, or if my minister suspects I may be a danger to myself, or others, he/she may report the situation to the proper authorities as mandated by law.

I am responsible for my own behavior, memories and life decisions. I take full responsibility for the results of my decisions, good or bad for my life.

The Wilmington Healing Center offers no guarantee for healing or deliverance.

I understand Wilmington Healing Center does not offer urgent care, emergency prayer, aftercare or mental health services.

I understand my minister may consult with Wilmington Healing Center staff, and other ministers and/or professionals about me for counsel and guidance on my behalf confidentially.

The Wilmington Healing Center ministers reserve the right to discontinue ministry at any time for any reason. I acknowledge that active occult behavior may immediately terminate the ministry relationship.

Appointment Policy

- 1) Ministry services are provided by appointment only.
- 2) To cancel or reschedule an appointment, please provide at least 24-hour notice.
- 3) Missed appointments could incur a one-hour fee (Discretionary).
- 4) Please limit phone calls and texts to the following guidelines:
 - a. *Appointment scheduling, cancellation or rescheduling*
 - b. *Operating hours are Monday through Friday 9 to 5 pm (Pacific Time).*
 - c. *We will respond to calls and texts during these hours. We are not open on the weekend so we can rest and rejuvenate from the demands of ministry during the week. As much as we love each person we serve; we aren't available for urgent or emergency support unless previously arranged directly by the minister. Please keep a mental health services number handy or dial 911 for emergencies.*

- f. *The suggested donation for service is \$50 per hour.*
